The Annual Town Meeting was called to order by First Selectman Gary Greenberg at 7:09 p.m. Present were Gary Greenberg, First Selectman, Chris Demorit, Wendy Sears, Selectmen, Jean LeFebvre, Treasurer, MaryAnn Fitzsimmons, Assistant Treasurer, and Wendy O'Connor, Assistant Town Clerk, and members of the audience.

- 1. To elect a moderator. First Selectman Greenberg called for nominations.
 - Motion to nominate Monica Lindsey was made by Cassidy Martin, 2nd by Gracie Martin. No other nominations and nominations were closed. Motion carried unanimously.
 - Moderator Monica Lindsey reviewed the meeting rules before proceeding.
