- I. Kisluk stated that the property is under contract, and she has been in contact with the owner, surveyor, and applicants. The wetlands have been flagged on the property and a percolation test for the septic system has been scheduled. I. Kisluk stated that they had considered another location for the driveway off of Pinch Street but they decided on their proposed location so that the field could still be used for agriculture in the future. She stated that the current property owner accesses the property mainly through his adjoining land so there is currently no established access or driveway.

A. McLevy asked how large the watershed is in the area. I. Kisluk showed the Commission the aerial photography and contours of the general area.

A. McLevy asked why the wetlands flags stopped on the map toward the south of the property. I. Kisluk stated she would have the soil scientist sign the final plans and would follow up on the termination of the wetlands flag. The Commission scheduled a site walk at this property for October 13 or October 20 at 5:30 P.M. depending on the applicant's availability.
