## A. Discussion of existing, proposed and future Scotland Zoning Regulations.

The Commission reviewed the final revisions to proposed regulations regarding Farm Wineries:

- 8.19.3.b "The hours of operation of the Retail Sale of Wine and Tasting Room shall be 10 am to 44 10 pm daily".
- 8.19.3.d.6 "All refuse containers shall be screened from view from offsite and located no closer than fifty (50') one hundred (100') feet from any property line and no closer than one hundred (100') two hundred (200') feet from any dwelling on an adjacent lot".
- 8.19.3.d.7 "All entertainment and audio amplification shall occur within the principal Farm Winery and Vineyard building and shall not be audible from outside the building; or, if in an outdoor area or audible outside the building, shall be terminated at least one (1) one-half (1/2) hour prior to the closing times set forth in paragraph (4) above.
- 8.19.4 Add employee parking, as needed.
