- C) **Financial Review:** Business Manager Liz LaVia noted that the Town has entered its 3rd fiscal quarter and tracking as expected. The budget mailer will be sent out April 11,2025. No other business to report.

Information & Discussion:

A) Tim Laughlin Sherman School renovation report/request: Tim Laughlin was unable to attend the meeting due to attendance for a Planning and Zoning meeting related to the renovation project. During a June 2024 Town meeting, the BOS allocated \$50,000 from the CNR Fund for expenditure related to summer repairs. There is a remaining balance of \$35,000 from the June request that the BOE would like to use for 2 new/different expenses unrelated to summer repairs.

Motion: For the BOS acting as the Board of Finance to approve use of funds authorized at Town Meeting on June 13,2024 for electrical enabling and repair work permitting the installation of air conditioning to mitigate temperature and humidity, security features related to access control, alarm systems, and fire safety alarm systems in the area of Sherman School that will be used as a temporary school facility, and fire suppression tank inspections.

A1) Emergency repairs for the school:

Motion: To allocate a number not to exceed \$35,000 from the CNR Fund for use by the school and BOE for the following: electrical enabling and repair work permitting the installation of air conditioning to mitigate temperature and humidity, security features related to access control, alarm systems, and fire safety alarm systems in the area of the Sherman School that will be used as a temporary school facility, and fire suppression tank inspections.

- B) **SVFD monthly:** Fire Chief Chris Fuchs was unable to attend the meeting, but he provided First Selectman Don Lowe an overview of the month's activities. The firefighters trained on searching and removing victims from a burning building using their self-contained breathing apparatus and radio communications. Emergency medical technicians and responders conducted a CPR recertification and trained on how to care for patients who have suffered a stroke. There are 2 members finishing their EMT certification course, 1 member beginning EMT certification, and 1 member beginning FF2 class. Lastly, the public is reminded to obtain a burn permit through the Fire Marshal office and to check daily weather conditions prior to burning.
- C) **Public Works report**: PW Supervisor Kris Fazzone provided a review of the department's daily maintenance. He informed that road sweeping and pot hole filling are in the works. Chip sealing will begin in the next couple of weeks and a Nixle will be sent to inform residents of any road issues/traffic. Park maintenance has begun and tree work will also continue until the budget is maxed out. Discussion on paving Anderson Road will be addressed at the next BOS Monthly Meeting.

- **C1) Orange Pepper Road discontinuance**: The Town must warn neighboring residents 30 days in advance that the property in question is up for a vote of discontinuance. The BOS have tentatively agreed that May 20, 2025 a Town Meeting will be warned to discuss the issue. The meeting will provide neighbors/residents clarity on details surrounding the expectation for the discontinuance.
- D) Park and Recreation discussion and resolution regarding summer camp fees: The BOS, upon discussion during budget workshop meetings, agreed that offsetting some of the financial deficit of Park & Rec could be attributed to marginally raising summer camp fees. Neighboring town fees were considered in the decision process. Park & Rec argued that due to upcoming town expenses (school renovation, potential large capital expenses) this current summer was not ideal to visit changing camp fees. The commission believes that the camp provides residents with something unique without being costly. The BOS noted that increases in minimum wage, supply costs effect budgeting accurately. With much collaborative discussion, the BOS and Park & Rec Commission agreed that keeping camp fees similar to the 2024 season but add a late penalty fee for anyone who signs up after May 20, 2025. For residents it will be an additional \$75 and \$100 for out of town participants after May 20th. Confirmation of the changes will be discussed at the next Park & Recreation scheduled meeting on April 12, 2025.
- E) Emergency SVFD repair for \$7005.64 to go to Town Meeting:

- L) Proposed Sherman Senior Center update: The committee is working on determining the cost of the overall project, an RFP went out for a Construction Manager. Information can be found on the Town website in regards to the RFP.
- M) Town Beach dock additions and redesign work update: No new movement, the plans are still with FirstLight and waiting for approval to FERC. Money has been previously approved for FERC application.
- N) **Traffic enforcement**: 52 stops have been recorded for the month, enforcement continues.
