THIS REFERENDUM WILL BE HELD IN THE SHERMAN EMERGENCY
SERVICES FACILITY.

WHO IS ELIGIBLE TO VOTE IN THE REFERENDUM?

1. Registered voters of the Town of Sherman. (There will be no voter registration after December 5, 2025.)
2. Property owners who are U.S. citizens, 18 years of age or older and who have property assessed at \$1,000 or more on the last-completed Grand List of the Town of Sherman. (The last-completed Grand List of the Town of Sherman is October 1, 2024.)

ABSENTEE VOTING IN THE REFERENDUM.

1. Absentee ballots will be available beginning Tuesday, November 25, 2025 thru Friday, December 5, 2025 during regular office hours at the Sherman Town Clerk's Office.
2. Absentee ballots must be picked up at the Town Clerk's Office during regular office hours. They cannot be mailed out by the Town Clerk. You may designate certain people to pick up a ballot for you if you cannot do so yourself. Contact the Town Clerk's Office for details.
