## Meeting Minutes November 12, 2025

Meeting called to order by Chairman Weid at 6:06pm.

Minutes: A motion was made by Commissioner Campbell and seconded by Commissioner Flaherty to accept the minutes of September 10, 2025 as read. There was no meeting in October. No discussion on the motion. Motion carried 5/0.

Correspondence: Our new First Selectmen is coming to our December meeting to introduce himself.

Approval of Bills: Following careful review by the commissioners a motion was made by Commissioner Whalen and seconded by Commissioner Campbell to pay the bills as presented. No discussion on the motion. Motion carried 5/0

Treasurer's Report: A motion was made by Commissioner Whalen and seconded by Commissioner Campbell to accept the treasurer's report as read. No discussion on the motion. Motion carried 5/0

TVAC Report: Unit One has 1490.7 miles, Unit Two has 42,919.5 miles and E-140 has 27,414.8 miles. A new member, Austin Childers, was voted in as a full member. Calls to date totaled 1173. The floors were washed and waxed and carpets cleaned. The bathroom and bay floors will be done next. New pillows, mattress pads and lamps will be ordered for the bunk rooms. The new fly car has been delivered and is out getting graphics applied. We hope to have it in service within the next 30 days. Daniela is getting an iPad as a ToughBook replacement.

Building Report: The weather stripping around the overhead doors in the bays are stripped and the air is coming in all around them. You can see into the building. We will be calling to have this repaired, also checking on the remotes for the doors.

Vehicle Report: We are talking about keeping the broken, fixed Unit two as a third ambulance and keeping the old fly car as a vehicle for Daniela. The ambulance hit a car that was parked, there was no damage to either vehicle, however, no report was made. Vintec was notified and asked to notify all drivers a report has to be made out for any incident no matter if there is damage or not.

Old Business: Nothing to report at this time.

New Business: Floors and carpets have been done. They will be back to do the bathrooms and bay floors. We have new protocols for airway equipment and will be purchasing this equipment for \$5,000 or less.
