## **SPECIAL MEETING**

**Present:** Ch. Mueller, V. Ch. Fainer, Comms. Leduc, Lascko, Scott Amendola of Unimetal, Plant Mgr. Galpin and Office Admin. Tammie Ireland

Ch. Mueller called the meeting to order at 7:09 pm.

Scott Amendola reported that they continue to see improvements with the usage of the clay, he provided the Commission with a graph showing the process. The ZLD is still halfway across the ocean and should be here sometime in December or early January.

Tighe & Bond contacted Mgr. Bert to report that the I & I part of the flow study should be done this week or early next week. Preliminary report is that 40/50% of our flow is from I & I.

#### **B. Treatment Plant**

Process is running ok. SBR sludge waste valves are complete. Operator Craig cleaned the PAC piping. The crew used the vac truck to clean the PAC tanks. The crew all reported to the Town Hall for a meeting with First Selectman Rich Sileo. The operators repaired floats on the cables to the SBR mixers. Traver Electric came to repair the faulty somat pump. Stonkus Hydraulics came in and completed a service on the SBR valves. On call operator Craig was called in for a power fail at the plant.

### **Pump Stations**

The crew had to replace a bad transducer at Highwood pump station. Operators Matt P and Matt B cleaned all pump station transducers. Northeast Generator replaced a bad block heater. On call operator Brett was called in for low level alarm at Electric Ave pump station.

### **Collection System**

The crew continues working on mapping and jetting for CMOM. The crew continues to clear the right of ways for the season. The crew jetted and vac Pine Hill Rd for routine maintenance.
