REGULAR MEETING
WPCA PLANT 258 OLD WATERBURY RD THOMASTON CT 06787
7:00 PM TUESDAY, JANUARY 21, 2025

Present: Ch. Mueller, V. Ch. Fainer, Comms. Piscopo, Chandon, Leduc, Lascko, Scott Amendola of Unimetal, Atty. George Seabourne, Tim Bobroske of Reynolds Bridge Rd, Plant Mgr. Galpin and Office Admin. Tammie

Ch. Mueller called the meeting to order at 7:01 pm.

On a motion put forth by V. Ch. Fainer to accept the minutes from December 17, 2024, with corrections to page one paragraph 7 & 8 and page 2, last paragraph. 2nd by Comm Lasko. Commissioners Lasko and Chandon abstained. Motion passes.

On a motion put forth by V. Ch Fainer to move Tim Bobroske above Consultant Report, 2nd by Comm. Lascko. Motion passes.

Atty George Seabourne spoke on Mr. Bobroske's behalf, they are looking for a vote, yes or no to the application for 18 units on Reynolds Bridge Rd. Per Ch. Mueller, the application just needs to be tabled until the flow study is completed, we cannot approve the application due to the recommendation by the State of Connecticut DEEP, for our plant to hold off on adding any new flow to our plant until the flow study is completed. Atty Seabourne is concerned this decision can take years and they would like a yes or no instead of tabling. Atty Seabourne would like to know if the commission will be putting a moratorium into effect. He feels that the public should be put on notice if we will not be accepting any new applications until after the flow study is completed. Comm. Piscopo indicated that he will propose to add this to the agenda under new business and discuss the possibility of a moratorium. Mr. Bobroske feels that we are not allowing him to use this property and if the engineered map we have on file allowed for 18 units, why can he not move forward? Manager Galpin explained that the engineered map is from approximately 10 years ago, the plant, at this point, cannot handle the additional flow. On a motion put forth by Comm. Chandon to table the decision on the application until we have the flow study results in. 2nd Comm by Lascko. Motion passes.

On a motion put forth by Comm Leduc to move Unimetal above Consultant Report, 2nd by Comm Piscopo. Motion passes

Scott Amendola of Unimetal has continually been sending emails to Mgr. Galpin regarding exceedances. He also said the shutdown was a success, the clarifying tank was cleaned and zeroed out. They continue to slowly move forward with the ZLD by working with the combination consultant. The best guess for this to begin is July 2025. Mgr. Galpin asked if they would be looking to maintain some of their

discharge once this new process begins, Mr. Amendola said yes, they would be maintaining some of their discharge.
