- * 508 Main Street has attracted a prospective developer. Information from a June 15th meeting will be shared with the BOS in the near future.
- * Annual Reviews of staff report directly to the Town Manager have been completed. The Board was informed of the resignation of Collector of Revenue Halaree Monnerat.
- * Batcheller School will be returned to the Town effective June 30, 2022. A building wide tag sale will be held on June 28th to help reduce the expense of removing contents.
- * Official word has been received that the Town is approved for Community Challenge Grant reimbursements back to April 7, 2022 and project planning can commence.
- * E-Code responses have been sent back and next steps will be announced over the next few months.

- * Momentum continues to build on the efforts of EDC Director Ted Shafer and the EDC team. Prospective businesses have been approaching the Town with both start up and relocation questions. A manufacturers roundtable yielded suggestions to expand workforce housing and increasing marketing and advertising of the Town.
- * The Façade and Business Start Up Programs still have funding available with award recipients being finalized and announced during the coming month.
- * The Town continues to actively seek Grant opportunities. Staff have identified five targets to pursue.
 - 1) Community Investment Fund 2030
 - 2) Reconnecting Communities (US DOT)
 - 3) Community Facilities Direct Grant Program (USDA)
 - 4) T-Mobile Hometown Grant
 - 5) Small Town Economic Assistance Program (STEAP)

Below you will find a list of updates that highlight activities occurring around town since the Board last met and some reminders of activities that occurred in the prior month or that are coming soon. If you have any questions about these items or items that do not appear on this list, please email me at townmanager@townofwinchester.org.

Cat Hoarding Situation: As of the authoring of this report (morning of Friday, July 1), the Town had approximately 31 cats in its possession from the hoarding case that has been widely publicized. At its height, the Town had over 90 cats in its possession at Batcheller School (the site of our makeshift shelter for these animals) with another 60+ placed directly into shelters without being brought to Batcheller at all. Overall, including the cats that we continue to work to humanely trap and relocate away from the site of the hoarding situation, we estimate that this case involved 180+ total cats, 2 dogs, and 1 ferret. Of the 31 cats currently in our possession, most have either (1) had an adoption application approved which will allow the cat to go directly into a home once spaying or neutering is complete, or (2) have a shelter that has identified them as a cat they will take in as soon as space can be made available. That leaves somewhere between 5-10 cats currently in our possession that do not have an assigned place to go. These remaining cats remain, by law, the Town's responsibility, and they will remain in our care until they are either adopted out directly from the town or they are placed in a shelter. The dogs and ferret have already been placed in shelters. The Town is taking on significant costs related to cat care, especially veterinary care, and we appreciate all the community support that has been expressed to date through donations of supplies, cash, and checks. If anyone else wishes to help, they can make a cash or check donation at Winchester Town Hall (338 Main Street, Winsted, CT 06098). Checks should be made out to "Town of Winchester, CT" with "Animal Care" in the memo line. Anyone who wishes to adopt a cat should send an inquiry to townmanager@townofwinchester.org; we may not have cats in the Town's possession available for adoption at the time you reach out, in which case we will send you a list of other rescues and shelters where over 100+ cats were brought. Due to the magnitude of this event, the rest of my report is relatively light and many

other projects were placed on hold while the town's coordinated response to this case was executed. A special thank you to the CT Department of Agriculture, the many municipalities that extended mutual aid to this effort, the many shelters that have already taken in well over 100 animals, and the individuals who have donated an inordinate amount of time, money, and supplies to support our efforts to make sure these animals are placed in happy, healthy homes. This process continues, but we would not have been able to get to this point without help from each and every person and agency involved.

- 508 Main Street: The process to get this site revitalized continues.
- ARPA: I am currently in the process of collecting more information that the Board of Selectmen has requested, and further requests for ARPA allocations will come once that information is collected.
- **Batcheller School:** The Town is currently using the gym in this school as a makeshift shelter for the cats from the hoarding situation. Aside from that, the Town is busy working to develop an RFP to market this space.
- Communities Challenge Grant: The Town has officially received word that expenditures made on these projects can be reimbursed back to April 7, 2022, meaning that planning work may now commence on these projects.
- Economic Development: More businesses continue to reach out about opening up new ventures here in Winchester, and we continue to work with them to find ideal storefronts/locations and help them through approval processes.
- Façade & Business Start-Up Programs: The Town still has \$50,000 dedicated to its Business Start-Up Program that are unawarded. We are working diligently to use this money to attract new and expanding businesses to Town, and we have our sights on using this money to attract specific kinds of businesses that will improve the Main Street experience and quality of life in town. Five new businesses have already accepted awards as part of this program. A list of new Façade Improvement Program award recipients is being finalized and will be announced soon.
- Fair Rent Committee: A list of participants for this committee is being finalized.
- Insurance: While the Town has had a very positive, long-standing relationship with CIRMA, I am happy to say that the Town has evaluated a wide array of options and has found great cost savings, with identical coverage, by switching to Travelers for general liability insurance. These savings will be realized immediately in FY 2023. We continue to evaluate all such contracts on a rolling basis in an effort to find improved services and cost savings for the Town.
- **Personnel:** We are actively seeking a Building Official, and interviews for the Town Planner position are ongoing. Other personnel work including the updating of job descriptions, improving Civil Service operations, and updating service contracts continues on a routine basis. As always, Selectmen are encouraged to reach out to me with any questions, and I am always available to sit down in-person or speak with you remotely.

New Addition:

Section 711 – Town Clerk

The Town Manager shall hire and may remove, subject to such rules and regulations as may be adopted pursuant to the merit system provisions of Article XII of this Charter, and the State Statutes, a Town Clerk who shall perform such duties as may be prescribed by the State Statutes, the Board of Selectmen, or the Town Manager.

Original:

Section 801. SALARIES Salaries of all Directors and other employees of the classified service of the Town shall be determined by the Board of Selectmen, in conformity with a systematic pay plan for the positions involved, upon recommendation of the Town Manager, providing nothing herein shall be construed to limit the power of the Board of Education to fix the compensation of employees of the school system. The Town Clerk shall receive a salary in lieu of all fees, and such salary shall be determined by the Board of Selectmen.

Changes:

Section 801. SALARIES Salaries of all Directors and other employees of the classified service of the Town shall be determined by the Board of Selectmen, in conformity with a systematic pay plan for the positions involved, upon recommendation of the Town Manager, providing nothing herein shall be construed to limit the power of the Board of Education to fix the compensation of employees of the school system.

The Town Clerk shall receive a salary in lieu of all fees, and such salary shall be determined by the Board of Selectmen.

Original:

Section 1708. DEFINITIONS OF VOTERS AND ELECTORS As used in this Charter an "Elector" means any person who is an Elector of the Town or a property owner of the age of eighteen (18) years or more, who, jointly or severally, is liable to the Town for taxes assessed against him on an assessment of not less than one thousand dollars on the last completed Grand List, or who would be so liable if not entitled to a statutory exemption.

Changed:

Section 1708. DEFINITIONS OF VOTERS AND ELECTORS As used in this Charter an "Elector" means any person who is a Registered voter in the Town of Winchester or a property owner of the age of eighteen (18) years or more, who, jointly or severally, is liable to the Town for taxes assessed against him on an assessment of not less than one thousand dollars on the last completed Grand List, or who would be so liable if not entitled to a statutory exemption.

Original:

Section 601. BOARD OF TAX REVIEW There shall be a Board of Tax Review which shall consist of three (3) members. The Board of Selectmen shall, each October, appoint one (1) member to the Board of Tax Review for a term of three (3) years. Said Board of Tax Review shall have the same powers and duties and shall, in equalizing and adjusting valuations assessment lists, proceed in all respects as though elected by ballot for and on behalf of the Town of Winchester. Any member of the Board of Tax Review may be removed from office by the Board of Selectmen for cause after hearing but, in case of such removal, the Selectmen shall cause to be recorded in the records of said Board a statement of the reasons therefor.

Changed:

Section 601. BOARD OF TAX REVIEW/BOARD OF ASSESSMENT APPEALS There shall be a Board of Assessment Appeals which shall consist of three (3) members. The Board of Selectmen shall, each October, appoint one (1) member to the Board of Assessment Appeals for a term of three (3) years. Said Board of Assessment Appeals shall have the same powers and duties and shall, in equalizing and adjusting valuations assessment lists, proceed in all respects as though elected by ballot for and on behalf of the Town of Winchester. Any member of the Board of Assessment Appeals may be removed from office by the Board of Selectmen for cause after hearing but, in case of such removal, the Selectmen shall cause to be recorded in the records of said Board a statement of the reasons therefor. Members shall serve without compensation.

Original:

Section 602. ECONOMIC DEVELOPMENT COMMISSION There shall be an Economic Development Commission which shall consist of seven (7) regular members and four (4) alternate members who shall be appointed by the Board of Selectmen. Both the regular members and alternate members shall serve for terms of five (5) years and shall be appointed so that no more than three (3) regular terms or one (1) alternate term shall expire in any one year. The first alternate members' terms shall be appointed respectively for one (1), two (2), three (3) and four (4) years. Any vacancy in the membership of the Commission shall be filled for the unexpired portion of the term by the Town Manager. The members of the Commission shall receive no compensation for their services as such but shall be reimbursed for their necessary expenses incurred in the performance of their official duties. The Commission may appoint employees necessary for the discharge of its duties. The Economic Development Commission shall exercise all powers set forth in Chapter 97 of the Connecticut General Statutes. The Economic Development Commission is further designated as the Development Agency of the Town of Winchester and shall exercise all the powers granted to such agencies as set forth in Chapter 132 of the Connecticut General Statutes. All actions taken by the Economic Development Commission prior to the effective date of this Charter are hereby ratified.

Changed:

Section 602. ECONOMIC DEVELOPMENT COMMISSION There shall be an Economic Development Commission which shall consist of seven (7) regular members and four (4) alternate members who shall be appointed by the Board of Selectmen.

The intent of the Board is to fill the 7 regular and 4 alternate membership slots with individuals possessing skill sets and qualifications related to the economic development of the Town of Winchester, within the following categories:

- Those representing the Winchester development community, commercial or residential
- Those representing the Winchester business community
- Those with land use or architectural expertise
- Those with marketing, public relations, communications, or tourism expertise

Both the regular members and alternate members shall serve for terms of five (5) years and shall be appointed so that no more than three (3) regular terms or one (1) alternate term shall expire in any one year. The first alternate members' terms shall be appointed respectively for one (1), two (2), three (3) and four (4) years. Any vacancy in the membership of the Commission shall be filled for the unexpired portion of the term by the Town Manager. The members of the Commission shall receive no compensation for their services as such but shall be reimbursed for their necessary expenses incurred in the performance of their official duties. The Commission may appoint employees necessary for the discharge of its duties. The Economic Development Commission shall exercise all powers set forth in Chapter 97 of the Connecticut General Statutes. The Economic Development Commission is further designated as the Development Agency of the Town of Winchester and shall exercise all the powers granted to such agencies as

Original:

Section 603. PARK AND RECREATION BOARDS A. Membership. There shall be a Park and Recreation Board, hereinafter the "Recreation Board", which shall consist of not fewer than nine (9) members nor more than thirteen (13) members appointed by the Board of Selectmen. A member of the Board of Selectmen, the superintendent of the town schools, the principal of the parochial school, and the principal of the Gilbert School shall be ex-officio members. Members shall serve for terms of six (6) years or until their successors are appointed except that the members of such Recreation Board first appointed shall be appointed for such terms that the terms of one-third of the members shall expire every two (2) years thereafter. Any vacancy occurring otherwise than by expiration of term shall be filled by the Selectmen for the unexpired portion of the term. The members shall serve without compensation. B. Rules and Regulations. Members of the Recreation Board shall elect their own chairman and secretary and all other necessary officers, each to serve for a period of one year. The Recreation Board shall have power to adopt rules and regulations for the conduct of all business within its jurisdiction. A majority of the members shall constitute a quorum for the transaction of business. C. Powers. The Recreation Board shall have power and authority to establish, maintain and conduct playgrounds, swimming pools, baths, bathing beaches, gymnasiums, recreation places, and public gardens and provide for entertainments, concerts and celebrations. It may use for these purposes any ground or building which the Board of Selectmen or Board of Education may from time to time, provide, acquire, authorize, offer, designate or set apart for such use by the Recreation Board. Said Recreation Board shall have the power, with the consent of the Board of Education and the trustees of Gilbert School likewise to use the school grounds, buildings or other facilities which may be offered either temporarily or permanently for playground and recreational purposes; and may receive donations and gifts from individuals, corporations or others for equipment, improvement, maintenance or supervision. Nothing contained in this paragraph shall be construed as taking away any powers of the Selectmen to establish, maintain, and conduct public parks, playgrounds, bathing beaches and other recreation places. D. Expenditures. All expenses incurred by the Recreation Board for the aforesaid purposes shall be payable from Town appropriations and from any private gifts that may be received. The Funds appropriated shall be credited to the Recreation Board account and may thereafter be expended by the Recreation Board with the approval of the Selectmen for the purposes enumerated above. Said Recreation Board, however, shall not expend or enter into any contract by which the Town shall become liable for any sum which shall exceed the total appropriation and credit.
