3. Bidding Conditions

The list of equipment offered for sale and its description has been compiled from available data, but there is no guarantee or warranty on the part of the Town of Winchester relative thereto as to number or quantity kind, character, description, condition, suitability for use for which it may be desired or in any other respect whatsoever. All material is sold "as is" and "where is".

Bidders are invited and urged to inspect the material to be sold prior to submitting bids. Reasonable opportunity is afforded for inspection up to the time bids close as specified in the invitation, but no labor will be furnished for such purpose. Under no circumstances will a refund or adjustment be made on account of material not coming up to the standard expected, nor will failure to inspect be considered grounds for claim.

Bids or withdrawal of bids submitted, if received by the Town after the submission deadline will not be considered. All bid prices should be stated in units of quantity specified. Unless otherwise specified, by submitting a bid, it is agreed that the bidder will allow thirty (30) days from bid opening date specified in the invitation for acceptance of its bid by the Town of Winchester.

4. Submission Requirements

Each bidder shall submit three (3) paper copies of the applicable form(s) on pages 4-5 of this document via mail or personal delivery to the Purchasing Agent, 338 Main Street, Winsted, CT 06098, no later than the date and time as marked at the beginning of this RFP. The sealed proposal shall be marked as "Bid Submission".

5. Award and Contract

Award(s) shall be made to the highest responsible bidder(s). The Purchasing Agent reserves the right to reject any or all bids in whole or in part, to award by item, groups of items or total bid, unless otherwise specified by the bidder, and to waive informality or technical defects, if in his judgement, the best interests of the Town of Winchester will be served. In case of error in the extension of prices in the bid, the unit price will prevail.

The purchaser shall assume all liability for equipment after an award is made. The Town of Winchester will exercise normal care for the protection up to the time limit for removal, but will not be responsible for any loss or damage from any cause whatsoever.

The successful bidder(s) will be required to make payment, by cashier's bank check, money order, or cash only, within 10 (ten) business days of the date of award unless other arrangements are

approved by the Purchasing Agent prior to that deadline. All checks or money orders must be payable to "Town of Winchester". Payment must be made in full in the office of Purchasing Agent prior to removal of equipment.

All material purchased must be removed within ten (10) working days of the notification date of the award. A receipt for payment must be shown to the appropriate Town personnel prior to removal of equipment.
