# 4. Public Hearings (cont.).

A. IWWC-25-18

Applicant: Shawn Stanziale Location: 504 E. Wakefield Blvd.

Proposal: Demolish existing house and detached garage; construct new house with attached garage, remove and replace retaining walls, remove and replace patio, regrade site, adjust driveway configuration, remove and reconstruct lake wall and steps, remove concrete and stone jetty, construct new walkways, install boatlift, jet ski lift, and dock.

Shawn Stanziale (owner and applicant) presented and clarified the project. The site plan has been adjusted to reflect a redesigned house and the applicant is requesting a permit only for the waterfront work at this time.

Kyle Case, P.E., KCC Consulting, spoke on behalf of the applicant.

Tom Grimaldi, P.E., for the Town of Winchester discussed his report.

Chris Samorajczyk, P.W.S., presented his findings and report for remediation of jetty removal

#### 5. Old Business.

A. IWWC-25-18

Applicant: Shawn Stanziale Location: 504 E. Wakefield Blvd.

Proposal: Demolish existing house and detached garage; construct new house with attached garage, remove and replace retaining walls, remove and replace patio, regrade site, adjust driveway configuration, remove and reconstruct lake wall and steps, remove concrete and stone jetty, construct new walkways, install boatlift, jet ski lift, and dock.

M.A. Marino made a motion to approve the removal and reconstruction of the lake wall and steps, remove the concrete and stone jetty, install boatlift, jet ski lift, and dock as shown on the revised plan dated. This approval does not pertain to the demolition of the house and garage nor the reconstruction of the same; with the following conditions:

- 1. A licensed soil scientist is to visit the property, take soil samples and analyze them, then resubmits the methods and means plan to Town Staff and Town's third-party Engineer,
- 2. Third party soil scientist must approve the methods and means plan and approve the suggested like materials used to restore the disrupted lake bed and oversees the creation of the like material before it is placed onto or into the lake bed.
- 3. All elements associated with the pier are removed to eliminate any safety concerns that relate to leaving any portion of the jetty on the lake bed;
- 4. Any elements of the jetty that are removed that are currently attached to the property at 502 E. Wakefield Blvd. are to be restored if affected by the work;
- 5. All conditions determined by the Town's third-party Engineer are met and complied with;
- 6. Third-party engineer and Town Staff must oversee the entirety of the project;
- 7. An erosion and sedimentation control bond is to be submitted in an amount to be determined by the Town's third-party engineer.

Applicant has agreed to adhere to all conditions placed on the property.
