1. Call to Order/Roll Call

Chair Stephen Molinelli calls the meeting to order at 7PM. In attendance are board members Russell Davenport (Vice Chair), Jackie Mulvey (Secretary), Jeffrey Lippincott, Frank Oliveri, Gary Paganelli, Mason Kiesewetter and Jamie Giantonio. 2. Approval of Minutes
