

Committee Purpose

- A roundtable of residents and staff from different backgrounds and specialties.
- Forum for open discussion of traffic safety issues and community concerns.
- Guide the Town's <u>future consultant</u> on priorities, including:
 - Identifying corridors and intersections of concern.
 - Highlighting vulnerable road users (pedestrians, cyclists, seniors, children).
 - Sharing local knowledge about crash patterns, near-misses, and safety "hot spots."
 - Recommending strategies for safer roadway design and operations.
 - Weighing trade-offs between cost, impact, and feasibility.
 - Promote community buy-in and transparency throughout the process.



Safe Streets for All

- Safe Streets for All (SS4A) is a U.S. Department of Transportation program that funds local efforts to improve roadway safety.
- Support communities in developing strategies that reduce fatalities and serious injuries on roads.
- SS4A provides funding for:
 - Planning and Demonstration data analysis of local crashes, mapping high-risk corridors, identifying strategies, etc. tailored to Winchester.
 - Implementation roadway surface improvements, crosswalks, parking improvements bike lanes, intersection redesign, traffic calming, improved lighting/signage, etc.
 - A community must first have an adopted Action Plan to be eligible for future SS4A implementation grants.



What is an Action Plan?

- A formal planning document with 75-150 pages.
- · Includes:
 - Crash data analysis and trends.
 - Maps and graphics showing high-crash corridors and intersections.
 - List of priority projects (short-, medium-, and longterm).
 - Strategies and policies to improve safety.
 - Implementation section: cost estimates, funding options, and timelines.
- Designed to be easy to reference for future funding applications.
- Developed by specialized consulting firms (transportation planners, engineers, safety analysts, and public engagement specialists).



What is Vision Zero?

- A roadway and traffic management strategy.
- Core principle: No traffic death or serious injury is acceptable.
- Focuses on system design, not just individual behavior:
 - · Safer street layouts and intersections.
 - · Speed management.
 - Infrastructure for people walking, biking, and driving.

Return on Investment

- ROI = SS4A Award / Town Match
- ROI = \$17,280,000 / \$4,320,000 = 4
- Leverage Ratio = 4 to 1 (80%/20%)
- Meaning for every \$1 the town invests; it receives \$4 in federal grant funding.
- Using the previous examples, the SS4A grants multiply the Town's investment, turning \$4.3M in local funds into over \$21.0M in total project value.

Question: Can we pave roads with SS4A money?

Answer: No, not routine repaving or general maintenance. SS4A isn't designed to fund basic resurfacing projects. However, paving can be an eligible cost if it's part of a larger safety improvement project identified in the Town's Action Plan. For example, if a project involves narrowing lanes, adding sidewalks, improving crosswalks, or redesigning intersections to reduce crashes, then paving associated with those roadway modifications is eligible. In other words, while we can't pave for the sake of paving, we can include paving as part of a safety-driven redesign.

Question: To what extent can SS4A Planning funds be used for engineering?

Answer: SS4A Planning funds can cover preliminary engineering and conceptual design work that supports the development of a Safety Action Plan and/or future Implementation Grant. However, they cannot be used for detailed design or construction-level engineering.

Question: Can SS4A funds be used to fix Main Street?

Answer: Potentially, yes. The Town's selected consultant will conduct a townwide roadway safety audit, not just focus on one road. However, if the audit finds that most safety concerns are concentrated along Main Street, the Town could apply for a future Implementation Grant to fund improvements there. However, this caliber of project may require a Supplemental Planning Grant.

Question: To what extent can SS4A money be used to fix Main Street (or any street)?

Answer: A future SS4A Implementation Grant could help fund a full reconfiguration of Main Street — for example, lane narrowing, "nose-in" parking, bike lanes, wider sidewalks, improved crosswalks, upgraded lighting, and new pavement markings. However, any such project would require significant coordination and approval from CTDOT, as well as a substantial local funding match from the Town. Again, this caliber of project may require a Supplemental Planning Grant.

Question: Can SS4A funds be used to hire more police officers?

Answer: No, SS4A funds cannot be used for personnel costs such as hiring or paying police officers. The program focuses on planning and infrastructure improvements that reduce crashes and improve roadway safety, not ongoing operational or staffing expenses.
