

**SEC. 51        PARKING IN ALLEYS AND PRIVATE ROADS REGULATED**

- (a) No person shall park a vehicle within an alley or road in private ownership and used for vehicular traffic by the owner and those having express or implied permission in such manner or under such conditions as to leave available less than 10 feet of the width of the alley or road for the free movement of vehicular traffic, and no person shall stop, stand or park a vehicle within an alley or such private road in such position to block the driveway entrance to any abutting property.
- (b) Any person who violates any provision of this Ordinance shall be subject to a fine of not more than \$50.00 for each violation.

**SEC. 52      AUTHORITY TO IMPOUND**

- (a) Members of the Police Department of the Town are hereby authorized to remove or cause to be removed any vehicle from a street or highway, or from an alley or road in private ownership and used for vehicular traffic by the owner and those having express or implied permission, to the nearest garage or other place of safety, or to a garage or other place of safety designated or maintained by the Town, when such vehicle is left unattended and is so parked illegally as to constitute a definite hazard or obstruction to the normal movement of traffic, or is so parked illegally as to impede snow removal operations for the Town, or is parked within ten feet of a fire hydrant in violation of the Connecticut General Statutes. Members of the Police Department of the Town are also hereby authorized to remove or cause to be removed any vehicle from a street or highway, when such vehicle is parked overtime and beyond the period of legal parking time established by the Traffic Authority, when signs are posted that vehicles so parked will be removed.
- (b) Such vehicle so removed may be recovered by the owner or his agent upon presentation of sufficient proof of ownership or authorization to obtain possession thereof and upon full payment of all removal and storage charges.
- (c) Whenever an officer causes the removal of a vehicle and the officer knows or is able to ascertain from the registration records in the vehicle the name and address of the owner thereof, such owner shall promptly give or cause to be given notice in writing to such owner of the fact of such removal and the reasons therefore and of the place to which such vehicle has been removed. In the event any such vehicle is stored in a public garage a copy of such notice shall be given to the proprietor of such garage.

**SEC. 53      DEVELOPMENT AND INDUSTRIAL COMMISSION**  
**ESTABLISHED**

The provisions of Section 263d of the 1955 Supplement to the General Statutes of Connecticut, Revision of 1949, Municipal Development and Industrial Commissions, are hereby accepted, and there is hereby established a Development and Industrial Commission for the promotion and development of the business and industrial resources of the Town of Winchester. Said Development and Industrial Commission shall consist of eleven members, who shall be appointed by the Board of Selectmen. The said members shall serve for terms of five (5) years.

**SEC. 56      PARKING AUTHORITY CREATED**

There is hereby created in the Town of Winchester a Parking Authority for the Town as provided by Section 281d of the 1955 Supplement to the General Statutes of Connecticut.

**SEC. 57      ALTERNATIVE MEMBERS OF PLANNING AND ZONING**  
**COMMISSION PROVIDED FOR**

The Planning and Zoning Commission of the Town of Winchester shall have three (3) alternate members, who shall be appointed by the Board of Selectmen, one of the original alternate members to serve for three years, one for four years, and one for five years, and thereafter each alternate member shall be appointed for a term of five years.

**ADOPTED AT SPECIAL TOWN MEETING HELD JUNE 8, 1964.**

**SEC. 58      NUMBER OF JUSTICES OF THE PEACE REGULATED**

Be it ordained by the Board of Selectmen of the Town of Winchester, Connecticut that the following Ordinance is hereby amended as follows:

The number of Justices of the Peace for the Town of Winchester shall be fixed at 30.  
Adopted at a Special Town Meeting held June 8, 1964; further amended at a meeting of the Board of Selectmen on May 6, 1996; effective May 26, 1996.



**SEC. 59      ORDINANCES PROHIBITING THE PEDDLING OF SOFT  
DRINKS, CANDY, CAKES, FRUITS, PASTRIES, ICE CREAM, OR  
FOOD OF ANY DESCRIPTION TO SCHOOL CHILDREN IN THE  
VICINITY OF SCHOOLS**

- (a) It shall be unlawful for any person, firm or corporation to peddle or sell soft drinks, candy, cakes, fruits, pastries, ice cream, or food of any description to school children between the hours of 8:00 a.m. and 5:00 p.m. on school days upon any public street, sidewalk, or any other public place in the Town of Winchester within three hundred (300) feet of any school property.
- (b) Any person, firm or corporation violating any provision of this Ordinance shall be deemed guilty of a misdemeanor, and upon conviction therefore shall be punished by a fine of not more than fifty dollars for each violation.

**EFFECTIVE JULY 1, 1965.**

**SEC. 60      UNIFORM FISCAL YEAR**

Resolved, that the Town of Winchester become a complying municipality as provided in Chapter 110 of the General Statutes of Connecticut, Revision of 1958.
