

Automated Traffic Enforcement Safety Devices (ATESD)


State Law

- C.G.S. 14-307c was approved on June 27, 2023
- This law allows municipalities to install Automated Traffic Enforcement Safety Devices (ATESD)
- Better known as speed cameras and red light cameras
- The full law can be found <u>here</u>



State Law

- The municipality must hold a public hearing on the ATESD plan and include the notice and minutes in the plan submitted to CTDOT
- Before submitting an ATESD plan to CTDOT, the municipality must adopt an ordinance authorizing ATESDs
- Locally, this means we must hold three (3) public meetings on the ordinance



Why does Winchester need speed cameras?

Speed Data

- In Spring 2025, we set up speed counters three locations:
 - Route 44 / Main Street Southbound
 - Route 44 / Main Street Northbound
 - Route 44 / Norfolk Road
- Counters were disguised so drivers wouldn't notice them and alter their behavior, ensuring an accurate measure of typical speeds for 5-6 days each

Bid Process

- Implementing an ATESD program involves equipment, installation, and administrative costs, so the Town initiated a formal bid process
- The Town published a Request for Proposals (RFP) in August 2025 to solicit qualified vendors for ATESD services
- The full RFP can be found here



Bid Process

- Our RFP sought a turnkey, end-toend ATESD provider to manage the program from start to finish
- Vendor responsibilities: site analysis, approvals, installation, maintenance, calibration, citation processing, and reporting
- The Town preferred a vendor-funded, zero-cost model with the provider assuming all financial risk



Bids Received

- The Town received proposals from the following four firms:
 - Sensys Gatso USA
 - Jenoptik
 - Sitestream
 - NovoaGlobal
- Various financial models were proposed; such as fixed fee models, revenue sharing models, License Plate Reader (LPR) add-ons, internal collection processes, contracted collection agencies, etc.
- Many models potentially left the town paying a bill with no revenue received

Sitestream Proposal

- Sitestream best fit the Town's preferred financial model: no installation or maintenance costs, no liability for unpaid citations, and collection fees fully covered within the vendor's revenue-share
- Sitestream is paid only after the Town receives payment. For each \$65 citation (\$50 first fine + \$15 processing fee),
 Sitestream receives \$35 and the Town receives \$30



16% more likely to get into accidents


According to drive-safely.net

- 1% of Sitestream program revenue remitted back to the client community twice per year
- Host community administers the program as it chooses for its teenage drivers that reside within the community
- Funds must be used for drivers educational purposes only
- No catches, no strenuous conditions and no maximum limits on program funding
- Possibility of lower insurance premiums after teens have completed a drivers education course

How will I know I am entering a speed camera area?

Signage Requirements

- There is no secret: C.G.S. 14-307c require municipalities to place at least two clear signs on every approach to a speed camera area
- The first will be 1,000 feet from the area
- The second will be 500 feet from the area
- Signs must adhere to FHWA standards – large, clear, and visible


Location #1: RT-44 / Main Street

Location #2: RT-44 / Norfolk Road




I received a citation. How do I pay it?

Paying a Citation

- Making a payment is easy!
- Forms of payment: Credit card, debit card, check, e-check, or money order
- Payments can be processed through Sitestream's portal:


- Accessible through web and mobile
- No personal data is required, only citation number and PIN which are unique to each citation



How will the Town use the collected revenues?

Use of Revenues

- C.G.S. 14-307c specifies how a municipality may use funds collected from speed camera citations,:
 - 1. To improve transportation mobility in the municipality,
 - 2. To invest in transportation infrastructure, or
 - 3. To pay costs associated with the automated enforcement devices themselves.



I received a citation. How can I fight it?

Appealing a Citation

- Practically, the process is like any other municipal citation
- Proposed Ordinance Article VI, § 157-29:
 "Any owner issued a fine for violating the
 provisions of this article may, within 10
 days of the receipt of the fine, appeal, in
 writing, to a citation hearing officer..."
- If a violator wishes to appeal the findings of the citation hearing officer, they may file with the Connecticut Judicial Branch



Citation Enforcement

- "Police Department employee or person designed by the Local Traffic Authority shall review and approve recorded images from the ATESD before a citation is mailed to the vehicle owner.
- For the first 30 days after an ATESD device is operational, the owner shall receive a written warning."

ATESD plan will be submitted to CTDOT for review March 2026

ctdot has 60 days to approve or reject the plan. If rejected, we will revise and resubmit

April 2026

If approved, installation of cameras and signs commences within 30 days

April – May 2026

30 days after activation, only written warnings are issued (grace period)

May + 2026

After the 30day grace period, regular fines begin being issued Annually 2026 +

Cameras will get a calibration reverification by certified operators ~ October 2027

The Town submits a report to CTDOT and state legislature

~ April 2029
