PISTOL PERMIT APPLICATION

Those individuals wanting to apply for a Town of Winchester Pistol Permit, pick up an application at the Winchester Police Department, or print from the Town of Winchester website. They will need to complete the application and return it to the Winchester Police Department with the following items:

- Signature on application <u>must be notarized</u> (notary must note his/her expiration date).
- Provide <u>COPY</u> of photo driver's license indicating <u>Winsted CT residency</u>
- Provide proof of your date and place of birth (<u>COPY</u> of birth certificate, passport or naturalization certificate.)
- Obtain and submit <u>COPY</u> of certificate of completion of an authorized pistol course.
- Non-Criminal Justice Applicant Privacy Rights and FBI Privacy Rights statements must be signed and dated before fingerprints can be taken.
- <u>Cashier check or money order</u> (<u>no personal checks or cash</u>) to:

YOU WILL NEED TO PRE-ENROLL AND PRE-PAY FOR THE PISTOL PERMIT BACKGROUND CHECK ON THE STATE WEBSITE: (total cost \$88.25)
GO TO: CCHRSPreEnroll, Service Code:1548-F29F

You must present your applicant tracking number before being fingerprinting

FINGERPRINTING IS AVAILABLE DAILY, DEPENDING ON THE AVAILABILITY OF STAFF.

Applicants should refer to Connecticut General Statute 29-28 for a complete list of all those people prohibited from receiving a permit to carry pistols or revolvers. Applicants should also be familiar with laws governing the use of force and proper storage of firearms (CGS: a-17, 53a-18, 53a-19, 53a-20, 53a-21, 53a-23, 29-27, 29-36k, 29-37i, 53-206d, 53-217, 53a-217b). If approved, applicant will receive a Town of Winchester temporary permit (60 days) to carry pistols and revolvers. Recipient may then apply to the State of Connecticut for a State of Connecticut permit to carry pistols and revolvers.

All pistol permit certifications must be dated AFTER 1994 and must include NRA

Upon approval, the local authority will issue a Temporary State Permit to Carry Pistols and Revolvers (DPS-11-C), effective for 60 days.		
Within the 60 day period, go to a DESPP, Division of State Police, pistol permit location and submit the following:		
 The Temporary State Permit to Carry Pistols and Revolvers (DPS-11-C) issued by the local authority; A completed Application for State Permit to Carry Pistols and Revolvers (DPS-46-C); \$70.00 fee, payable to Treasurer, State of Connecticut; Proof you are legally and lawfully in the United States (e.g., certified copy of birth certificate, U.S. passport or documentation issued by I.C.E.); and Proof of valid state issued photo identification card. 		
5. Upon approval, your photograph will be taken at DESPP and you will be issued a state pistol permit.

Noncriminal Justice Applicant's Privacy Rights

Requesting Entity: WINCHESTER POLICE DEPARTMENT

As an applicant who is the subject of a national fingerprint-based criminal history record check for a noncriminal justice purpose (such as an application for employment or a license, an immigration or naturalization matter, security clearance, or adoption), you have certain rights which are discussed below. All notices must be provided to you in writing. ¹ These obligations are pursuant to the Privacy Act of 1974, Title 5, United States Code (U.S.C.) Section 552a, and Title 28 Code of Federal Regulations (CFR), 50.12, among other authorities.

- You must be provided an adequate written FBI Privacy Act Statement (dated 2013 or later), by the agency that will receive your criminal history results, when you submit your fingerprints and associated personal information. This Privacy Act Statement must explain the authority for collecting your fingerprints and associated information and whether your fingerprints and associated information will be searched, shared, or retained. ²
- You must be advised in writing of the procedures for obtaining a change, correction, or update of your FBI criminal history record as set forth at 28 CFR 16.34.
- You must be provided the opportunity to complete or challenge the accuracy of the information in your FBI criminal history record (if you have such a record).
- If you have a criminal history record, you should be afforded a reasonable amount of time to correct or complete the record (or decline to do so) before the officials deny you the employment, license, or other benefit based on information in the FBI criminal history record.
- If agency policy permits, the officials may provide you with a copy of your FBI criminal history record for review and possible challenge. If agency policy does not permit it to provide you a copy of the record, you may obtain a copy of the record by submitting fingerprints and a fee to the FBI. Information regarding this process may be obtained at https://www.fbi.gov/services/cjis/identity-history-summary-checks and https://www.edo.cjis.gov.
- If you decide to challenge the accuracy or completeness of your FBI criminal history record, you should send your challenge to the agency that contributed the questioned information to the FBI. Alternatively, you may send your challenge directly to the FBI by submitting a request via https://www.edo.cjis.gov. The FBI will then forward your challenge to the agency that contributed the questioned information and request the agency to verify or correct the challenged entry. Upon receipt of an official communication from that agency, the FBI will make any necessary changes/corrections to your record in accordance with the information supplied by that agency. (See 28 CFR 16.30 through 16.34.)
- You have the right to expect that officials receiving the results of the criminal history record check will use it only for authorized purposes and will not retain or disseminate it in violation of federal statute, regulation or executive order, or rule, procedure or standard established by the National Crime Prevention and Privacy Compact Council.³
