

## TOWN OF WINCHESTER ZONING BOARD OF APPEALS Town OF Winchester Town Hall

#### 1. ROLL CALL:

Chairman Paul Marino called the meeting to order at 7:00PM, noting that the following individuals were present in addition to himself: John Pollack, Ron Dew, Paul Mitchell and Ryan Horvay as Alternates (Alternates were seated as voting members. Excused Absent Aubrey English & Ellie Gunn. Paul Marino abstaining from all voting)

### 2. EXPLAINATION OF PROCEDURE:

Mr. Marino explained that approvals from this Board require four affirmative votes from five seated members. Mr. Marino outlined the process of the meeting including the opportunity for the applicant to present their proposal, a chance for the Board to ask questions followed by the same opportunity for any member of the public that might be present wishing to do so. He explained to the applicant that there were only four Board members voting this evening offering them an opportunity to postpone to next meeting.

# 3. PUBLIC HEARINGS – VARIANCE APPLICATIONS & DECISIONS; APPEALS. A. ZBAE #23-2 Location: 221 Perch Rock Trail Owner/Applicant Frank Pizzo Proposal: Build 11'x13' Deck. Request for a 19.2' front yard set back Special Exception.

Frank Pizzo & Linda Jesse appeared before the Commission stating they wanted to build an 11'x13' patio to allow steps into cottage. Mr. Marino confirmed that the deck will not extend further toward Perch Rock or the Neighbors house at 223 Perch Rock than their house currently does. Applicants confirmed this to be true. Mr. Marino explained this was more of a deck than a patio, as it is a raised platform. Mr. Marino opens to Public. No Public comments, Mr. Marino closes to Public.
